3. Introduction on POLREC project

The POLREC project is a collaborative project between the 4 European clusters and a technological centre: [Polymeris](#) (coordinator), [CENTIMFE](#), [Cluster Mav](#), [PCD/DMN](#) and [WFG](#). It started on the 1st of September 2022 and will end on the 31st of August 2025. It is funded by the European Commission Joint Cluster initiatives for Europe's recovery (Euroclusters) under the Single Market Programme (SMP COSME) Grant Agreement 101074434.

It focuses on sustainable development and recycling of high and low value polymers as a contribution to the objectives of the European Green Deal aiming at zero CO₂ emissions in 2050 and to increase the European strategic autonomy on raw materials for polymer production.

During the project period of 3 years the consortium will explore how an intensified cluster and business network collaboration across borders and across sectors can meet this challenge and exploit the international business opportunities related to this topic.

3.1 Basic information about POLREC activities

POLREC will support companies on the following topics:

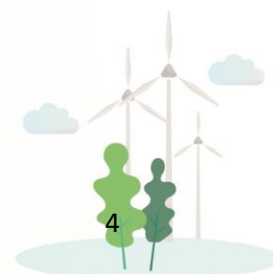
1. Network to improve the resilience of the EU industrial ecosystems by developing value chain interlinkages in the EU Single Market.
2. Innovate for strategic autonomy to build capacity in the most critical supplies of their ecosystems.
3. Adopt processes and technologies to reinforce transformation into a greener and more digital economy.
4. Train to foster up- and re-skilling of the workforce whilst attracting talents.
5. Go international to boost access to global supply and value chains.
6. Outreach to attract economic actors, mainly small or medium sized enterprises (SMEs), beyond Euroclusters' locations.

One of the means to provide this support is an open calls mechanism aiming to support European SMEs in developing solutions related to polymer & elastomer recycling, training on recycling technologies, networking and matchmaking in Europe and beyond.

3.2 Basic information about the POLREC Internationalisation Open Call

POLREC Internationalisation Open Call provides financial support to SMEs working in polymers & elastomers industries on recycling solutions (mechanical, chemical and digitalisation of process & traceability).

Under this Open Call, the POLREC consortium will select up to 50 SMEs for the networking sub-grant for a maximum total budget of 52,900EUR and 42 SMEs for the international match-making mission sub-grant, for a maximum total budget of 150 000EUR.





The call will open on 22/03/2024 and close on 22/05/2024 at 12:00AM CET. The link to the application documents and to submit your proposition can be found on the [Cluster Submission Platform](#).

The table below present the two sub-grant financing opportunities. An SME can apply to one or two of the sub-grants of the POLREC Internationalisation Open Call as well as for other POLREC Open Calls, provided that the total amount granted under different applications does not exceed 60,000€. An SME can submit only one application per sub-grant. In case an SME submits several applications for the same sub-grant, the last one will be the only one considered and evaluated by the POLREC consortium. The SME can send from the same account its two applications for the two Internationalisation sub-grants: Networking and International Match-making mission (one per sub-grant).

4. Scope and expectation

The POLREC Internationalisation Open call focuses on SMEs from plastic, rubbers and composites industries to facilitate their internationalization strategy and connect to new markets outside their national scope through the attendance and participation of business/trade fairs, exhibitions, conventions and a match-making mission organised in Canada.

The SMEs targeted by this call can cover various sectors, such as: transport and mobility, construction, renewable energy, digital and electronics, health, consumer goods, industrial and food packaging.

In brief, the POLREC Support Open call targets projects aiming to build international connections between SMEs, companies and R&D centres in- and outside the polymer industry.

4.1 Type of actions supported

Networking sub-grant:

The types of actions described below are within scope of obtaining a sub-grant. The types of actions listed are also referred to as sub-topics in this Guide for Applicants:

- Business/ trade fairs & exhibitions in Europe
- Conferences, conventions and forums in Europe
- Matchmaking events in Europe

The proposed event could target SME's across various sectors and lead to raising awareness within the polymer and elastomer industry towards recycling solutions and enhancement of the product life cycle. The event duration must be minimum 1 full day. A full day means a working day of 6-8 hours including lunch.

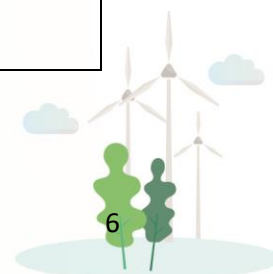
International Match-making mission sub-grant:

The SME will receive funding to cover its expenses for participating to the match-making mission organised in Quebec from the 3rd to the 7th of February 2025 by the POLREC consortium.

- **Financial contribution:**

The foreseen financial contribution is described below:

The total sub-grant receive for each applicant will be maximum 3,600€. After being awarded, each participant will sign the sub-grant agreement validating that they accept to follow the payment procedure described in section 6.2 according to the financial contribution described above. If the participant does not follow the payment procedure to the service-provider and the booking of flights and hotels within the required deadlines, the POLREC’s consortium reserve the right to remove the participant from the match-making mission, cancel its awarded sub-grant and award another participant from the waiting list.

- **Tentative agenda of the match-making mission**

The POLREC partners, led by Polymeris, will work in close collaboration with Canadian clusters from the plastics, composites and rubbers industries as well as internationalisation partners and a service-provider to organise the on-site visits and matchmaking meetings and ensure the relevance for the SME’s projects and activities.

The overall agenda of the mission with the arrival and departure date as well as the main milestone and events has been designed and can be find below as a tentative agenda for the match-making mission from the 3rd to the 7th of February 2025. This agenda is still under construction and will be more defined according to the participant’s needs and expectations. A final version of the agenda will be presented in November 2024 to all participants.

Please note that POLREC project partners reserve the right to modify the location of the hotels as well as the schedules of site-visits and matchmaking event. The dates of arrival and departure will remain unchanged so that participants can book their flights as soon as they receive the notification letter informing them that they are awarded. Participants can arrive earlier and leave later if they wish to schedule additional business meetings on Monday the 3rd of February 2025 or on Friday the 7th of February 2025 in the afternoon. Please note that any additional cost such as additional accommodation night or transportation will be at the participant’s own charge.

4.2 Expected impacts

The main impact of the project shall be to obtain a reduction in incineration and/or landfill of the SME's plastic and/or rubber waste fractions approaching the overall goal of a reduction in CO₂-emissions.

Applicants should be able to find new markets, new procurement opportunities or strengthening important business relationships in the European or Canadian market. The visits and delegations to countries outside of the applicants own country should lead to new projects, value chain collaboration to increase the use of recycled plastic or rubber materials or the use of products made from recycled plastic or rubber materials.

5. Eligibility conditions

To be eligible, applicants must satisfy all the following conditions:

1. Be a legal entity.
2. Be a small or medium sized enterprise (SME) in accordance with the [SME definition of the European Union](#). An SME self-assessment tool is available [via this link](#).
3. Apply as an individual organization.
4. Be a SME located in one of the Single Market Programme (SMP) associated countries
 - EU Member States
 - Other countries which participate in [SMP Work Programme/COSME Strand](#) (Link : https://ec.europa.eu/info/funding-tenders/opportunities/docs/2021-2027/smp/guidance/list-3rd-country-participation_smp_en.pdf)





5. For the Networking sub-grant: the participant representing the SME in the networking event must be over 18 years old. For the International Match-making mission sub-grant: the participant representing the SME in the match-making mission must be over 21 years-old.
6. Implement or plan to implement the recycling of polymer/elastomer wastes or digital solutions for recycling processes.

The SMEs targeted by this call can cover various sectors, such as: transport and mobility, construction, renewable energy, digital and electronics, health, consumer goods, industrial and food packaging.

Applications must be written in English and complete in all the parts indicated in application form. Only parts written in English will be evaluated.

SMEs that are under liquidation, in financial difficulty, or excluded from the possibility of obtaining EU funding under the provisions of both national and EU law, or by a decision of both national or EU authority are not eligible to apply for funding.

6. Funding conditions

6.1 Networking sub-grant:

Successful applications will receive the requested financial contribution in the form of a lump sum according to the following schedule:

- A final payment of 100% of the requested contribution will be provided after approval of the final activity report on the attendance of the networking event by the applicant. The approval will be made by the POLREC consortium.

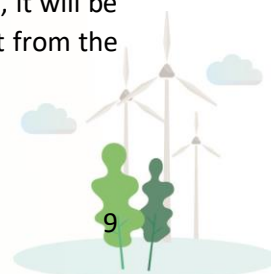
The approval process will check the achieved results mentioned in the final activity report submitted by the SME. Furthermore, a physical or remote meeting between the funded SME and POLREC partner(s) may be organised to better qualify the results.

The lump-sum will be attributed according to the number of days spent by the applicant at the event: for a 1-day attendance, the lump-sum will be 500 EUR, for a 2-day attendance: 1,000 EUR and for a 3-day attendance: 1,500€. A day is considered a full day of 6-8 hours of meetings, networking and visiting stands in a trade fair.

6.2 International match-making mission sub-grant:

Successful applications will receive the requested financial contribution in the form of a lump-sum according to the following schedule:

- A pre-payment of up to 1,250€ (depending on the final amount due for transportation as per table provided in section 4.1) from the total sub-grant will be provided to the awarded applicant after the proof of its payment of up to 1,250€ for the organisation & logistics support to the service-provider before October 2024. This financial contribution will allow the service-provider to pay the transportation, pre-book the hotels and restaurants and organise the events hold during the mission (catering, room booking, programme etc.). The pre-payment will be transferred in November 2024 by Polymeris, after receiving the proof of payment from the awarded applicant. If an awarded applicant fails to provide proof of payment within the required deadline, it will be removed from the matchmaking mission, its awards will be cancelled and an applicant from the waiting list will be awarded and invited to participate to the matchmaking mission.



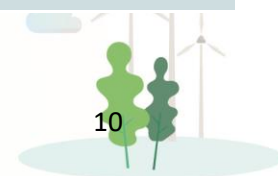


- The final payment of the remaining sub-grant (i.e. between 2,350€ and 2430€, depending on the amount of the pre-payment) will be provided to the applicant after its participation to the match-making mission and its completion of a report on the mission's impact on the internationalisation strategy of the SME outside the EU.

8. Application process

Applicants must submit their proposal for POLREC Internationalisation Open Call on the [Cluster Submission Platform](#) by logging in the platform and filling-in the required fields. If the applicant does not already have an account on this platform, it must create one to access to the application form. Once logged in, the applicant must complete the questions required by the platform and click on “Validate and Submit” at the end of the application process to submit its application.

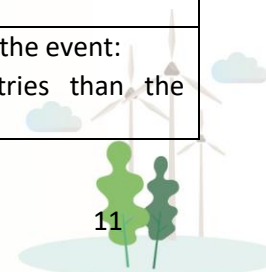
Applicants will receive an e-mail confirming that their application has been successfully submitted. Applications to the POLREC Internationalisation Open Call have to be submitted exclusively via the Cluster Submission Platform. No other documents are needed at this stage of the application process.

9. Evaluation and selection

Each application will be assessed by 2 POLREC project partners according to the following criteria.

9.1 Evaluation Criteria for the [Networking sub-grant](#)

A number of points from 1 to 4 will be assigned to each of the criteria. Only full scores will be given for each individual criterion. The meaning of the number of points is as follows:

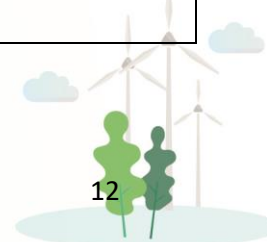
- 4 Exceeds expectations
- 3 Meets expectations
- 2 Needs development
- 1 Below expectations

The final number of points of each application will be calculated as an average of the individual assessment provided by each evaluator.

In order to be considered for receiving the sub-grant, the minimum threshold for each criterion will be 2 points and the minimum total pass note of 9 points out of the 16 total maximum points. Each criterion has a specific weighting score as described in the table above. The applications with the highest weighting total score will be selected within the limit of the available budget, in descending order. In case of equal scores, priority will be given to applications from SMEs located outside the POLREC's partners' countries. Obtaining the minimum pass note does not guarantee that the application will receive funding.

9.2 Evaluation criteria for the [International Match-making mission sub-grant](#)

Points from 1 to 4 will be assigned to each of the criteria. Only full scores will be given for each individual criterion. The meaning of the points is as follows:

- 4 Exceeds expectations
- 3 Meets expectations
- 2 Needs development
- 1 Below expectations

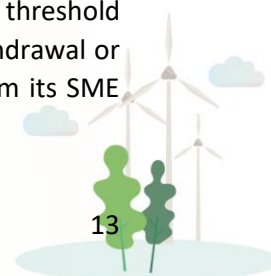
The final number of points of each application will be calculated as an average of the individual assessments provided by each evaluator.

In order to be considered for receiving the sub-grant, the minimum threshold for each criterion will be 2 points and the minimum total pass note will be 11 points out of the 20 total maximum points. Each criterion has a specific weighting score as described in the table above. The applications with the highest total score will be selected within the limit of the available budget, in descending order. Obtaining the minimum pass number of points does not guarantee that the application will receive funding.

9.3 Evaluation and Ranking for selected projects

After the external evaluation process, a ranking list will be defined where all the applications will be ranked according to their final scores. In the case of ties, priority will be given to projects with partners coming from countries outside of POLREC partner's countries, with a specific attention to EU-13 countries (Bulgaria, Croatia, Cyprus, Czechia, Estonia, Hungary, Latvia, Lithuania, Malta, Poland, Romania, Slovakia, Slovenia).

Successful proposals above the minimum pass score (per criterion and in total) are funded in descending order until the available sum for the call is totally assigned. The proposals that scored above the threshold but did not manage to obtain funding will be placed on a waiting list. In the event of the withdrawal or eviction of an awarded applicant due to its failure to provide requested document to confirm its SME





status or to follow the payment procedure, an applicant from the waiting list (in descending order) will be awarded instead and invited to sign a sub-grant agreement.

A Selection Committee composed of one representative of each POLREC partner will be reserved the rights to modify the ranking of successful proposals (in case of equal scores) to balance the list of selected projects according to geographical coverage and vertical sectors represented.

The final shortlist will be prepared by the POLREC coordinator (Polymeris) and POLREC partner - Wirtschaftsförderung Raum Heilbronn GmbH. The assessment period will take maximum 10 days starting from the closing date of the open call for the Networking sub-grant and 30 days for the International Match-making mission sub-grant.

9.4 Information to the applicants

Following the evaluation phase, the applicants will be informed about the outcome of the evaluations. The evaluation results will be sent to the main applicant's e-mail address associated with the application according to the Open Call calendar described in section 7 of the Guide for Applicant:

- A rejection letter in the event of the failure of the application.
- Or a notification letter for successful application. The instructions for the next steps will be described.

9.5 Complaint procedure

If after receiving the evaluation results an applicant disagrees with the result, a complaint can be sent (in English) to the project coordinator's e-mail (roxane.girard@polymeris.fr) within 3 working days following the official receipt of the evaluation result. The following information must be included:

- contact details and name of the application
- the sub-grant that was applied to
- the subject of the complaint
- information and evidence regarding the alleged breach.

In case a complaint is received, a re-evaluation will only be carried out if there is evidence of a shortcoming affecting the final decision on whether to fund the proposal.

The Review Committee will consist of the project coordinator Polymeris and Wirtschaftsförderung Raum Heilbronn GmbH. It will examine the complaint on the basis of the information brought forward by the applicant and decide whether the complaint is justified or not and will inform the applicant and the consortium on the decision taken.

If the complaint is considered justified, the Review Committee will notify 2 POLREC project partners, different to those which have done the initial evaluation, and ask them to re-evaluate the application and specifically the assessment part, subject to the complaint. The evaluators will then provide the Review Committee with an updated assessment. The final decision on the complaint will be communicated by the Review Committee to the applicant in writing within 14 working days from the date of submitting the complaint.

10. Signature of financial agreement and payment of the sub-grant

The winning applicants selected for funding will firstly have to provide an administrative document to prove their SME status in order to confirm their eligibility as well as the details of the bank account on





which the funding will be transferred. Applicants will have a maximum delay of 10 working days after receiving their notification letter to provide the requested documentation.

The POLREC Consortium will proceed to verification of these documents to make sure the selected applications are eligible in a delay of 15 working days.

10.1 Sub-grant agreement signature

If all eligibility conditions are met and confirmed, the SMEs selected for funding will be invited to sign a Financial Sub-Grant Agreement with the POLREC partner Wirtschaftsförderung Raum Heilbronn GmbH (WFG) for the networking sub-grant and Polymeris (POL) for the matchmaking internationalisation sub-grant. This Financial Sub-Grant Agreement details all rights and duties of the SMEs funded in the framework of the POLREC Internationalisation Open Call.

10.2 Payment procedure

Networking sub-grant:

The funding of 100% will be provided to the applicant no later than 10 working days after receipt and approval of the Final Activity report. Further details will be found in the Sub-Grant Agreement.

International Match-making mission sub-grant:

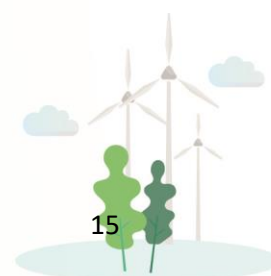
- A pre-payment of up to 1,250€ from the total sub-grant will be provided to the applicant after the proof of its payment of up to 1,250€ for the organisation & logistics support to the service-provider before the 31st of October 2024. This payment is dedicated to pay the transportation, pre-booking of the hotels and restaurants and organisation the events hold during the mission (catering, room booking, programme etc.) by a service-provider selected by the organisers. The pre-payment will be transferred in November 2024 by Polymeris, after receiving the proof of payment from the awarded applicant. If an awarded applicant fails to provide proof of payment within the required deadline, it will be removed from the matchmaking mission, the awarded grant will be cancelled and an applicant from the waiting list will be awarded and invited to participate to the matchmaking mission.
- The final payment of the remaining sub-grant (i.e. between 2,350€ and 2430€, depending on the amount of the pre-payment) will be provided to the applicant after its participation to the match-making mission and its completion of a short report on the match-making mission impact and international strategy outside the EU.

Further details will be found in the Sub-Grant Agreement

10.3 Implementation and reporting

Concerning the Networking sub-grant, the awarded applicants will visit the respective event they have chosen to participate in. Concerning the International Match-making mission sub-grant, the awarded applicants will participate to the matchmaking mission and the events organised prior to departure to present the programme and meet the other participants of the mission. The applicants will have to fill out the Final Activity report after attending the event or the matchmaking mission.

The beneficiaries must keep the original documents of their expenses in case of an audit for a period of at least 5 years after the end of the POLREC project (at least until end of August 2030).

To process and evaluate proposals, the POLREC consortium will need to collect personal and industrial data. The POLREC project coordinator will act as a Data Controller for data submitted through the Cluster Submission platform. [The Cluster Submission platform](#)'s system design and operational procedures ensure that data are managed in compliance with The General Data Protection Regulation (EU) 2016/679 (GDPR). Each applicant will accept the Cluster Submission platform terms to ensure coverage.

The final list of the awarded projects and beneficiaries will be made public, including name of the projects, abstract, legal name of the companies, sector, country/region of origins, results of the project and duration of the projects.

For dissemination and use of results generated through the financial support from POLREC, the SMEs must credit the POLREC project through proper citation and appearance of the POLREC logo and EU Logo, including the proper citation: "This project is funded by the European Commission Joint Cluster initiatives for Europe's recovery (Euroclusters) under the Single Market Programme (SMP COSME) grant agreement number 101074434".

13. Double funding

The SME applicant cannot apply for and/or receive funding outside of POLREC EUROCLUSTER for a similar project that could lead to a potential double funding of the same action. The POLREC EUROCLUSTER Consortium may carry out the necessary control actions with other SMP Eurocluster Consortia and other EU-funded projects to verify that there is no double funding ongoing.

14. Financial Capacity

The SME applicant must have the financial capacity to carry out the actions described in their proposals and to properly manage the financial support granted to them.

Each SME must be in alignment with the following situations:

- ✓ Is no bankrupt or being wound up, is not having affairs administrated by the courts, has not entered into an arrangement with creditors, has not suspended business activities, is not the



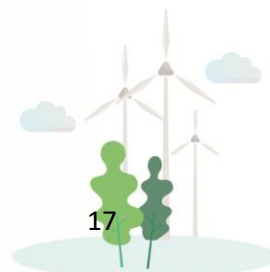


- subject of proceedings concerning those matters or is not in any analogous situation arising from a similar procedure provided for in national legislation or regulations;
- ✓ Is in compliance with its obligation relating to the payment of social security contributions and the payment of taxes, in accordance with the legal provisions of the country in which it is established;
 - ✓ Is not subject to a conflict of interest in connection with the grant.
